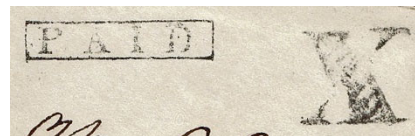

Laurens C. H. Stampless Markings (not to scale)

The different markings are identified by the 2012 *Confederate States of American (CSA) Catalog and Handbook* Stampless Type. The letters "X, Y, and Z," are used to designate added items not in the CSA Catalog. The absence of a CSA Catalog Type in the illustrations above indicates that item is not included in the census.

Items are presented in the census in the order of the illustrations above.

This census is based on images of covers. Only covers for which an image was obtained are listed in the census. For this reason, this census may be far from complete.

NOTICE: The Type B and C markings were also used for provisional covers. Provisional uses are identified by an undated Laurens postmark control on the reverse

NOTE: Every effort is made to ensure the accuracy of the census, but the inclusion of an item is not a guarantee of authenticity.

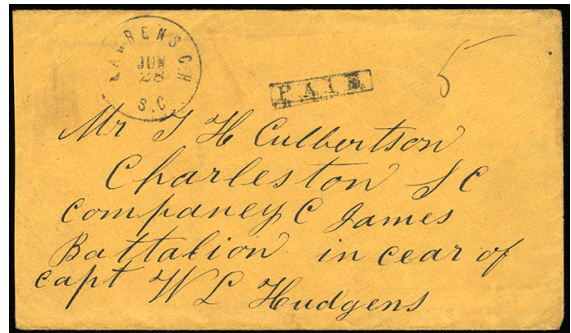

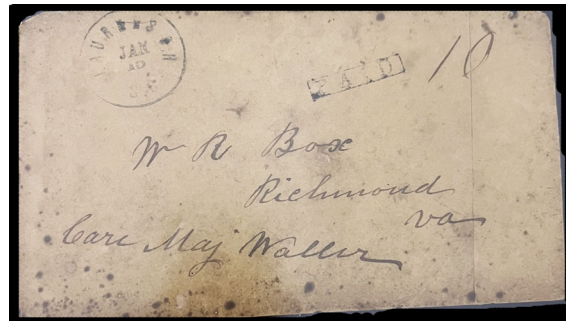

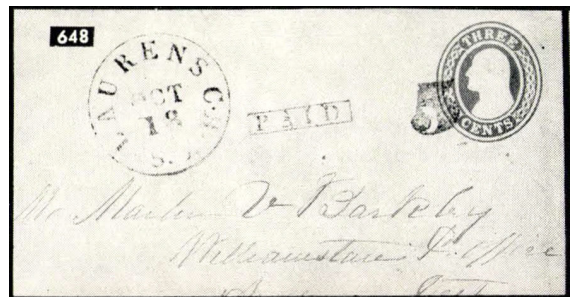
