There is little known about the straight-line postmarks. The only study of the markings was done by Conrad Bush, first in a series of articles in the *Confederate Philatelist*. and then in a book (see 'References' in the "Notes" Section).

Order: The straight-line cancels are listed alphabetically by postmark and within a postmark chronologically by stampless type and then stamp type. Only covers are listed in the Mini Census and Last Name Index.

Caution: Authentication certificates were found for only a few of the straight-line cancels listed in this census. It is easy to fake a straight line cancel. Readers are advised to consult with an authentication service before purchasing a straight-line cancel.

NOTE: The inclusion of an item in this census is not a guarantee of authenticity.

Notes

Goodson, Virginia

Goodson is unusual because it produced three straight line postmarks: two with month dates ("SEPT" and "OCT") and one without a month date. There is no explanation for the three varieties.

Based on the stamps used with these markings the covers date from April 1863. There is one recorded use of two 5c De La Rue local prints and a 10c stampless cover, but these could have easily been used in 1863.

Hardeman, Texas

There is a second Hardeman straight line cancel. Dietz wrote in 1938 a "second Hardeman cover is franked with a pair 5c De La Rue Local Prints, twice cancelled with the typeset [straight line] form, but not tied, while in the left upper corner the impression again appears with "17 Nov/62" in manuscript below. See Dietz in "References" below.

Hatchechubbee, Alabama

There are two varieties known: With the state abbreviation and without. Conrad Bush gives the period of use as March 1863, to November 1863, but acknowledges other periods may exist. See Bush in "References."

Jackson, Mississippi

There are two major types of the Jackson straight line marking: a large and small. The CSA catalogs list two types of the large marking, with a ball on the "J" and with the ball missing. This can be a subjective call and for that reason no distinction is made between the two in this census.

Conrad Brush wrote that there were two types of the small JACKSON postmark. One with the state abbreviation "MISS" and the other with "MIS." See Bush in "References." Below the reader can compare what appear to be examples with "MIS" and "MISS." Both are difficult to read.

Montpelier, Virginia

The use of this postmark is unusual. There is only one recorded use of the marking to cancel a stamp, and it is off cover. Strangely it was canceled twice. Two other uses are on covers with stamps pen cancelled. The third cover is a forwarded cover with no evidence of the original postage being paid.

There has been some debate about whether the cancel is a stenciled marking or not. The answer may be a matter of semantics. The cancel looks like stencil like. But such markings can either be made from a stencil in the conventional manner or carved in wood in a stencil like form. See Bush and Milgram in "References" below.

Tupelo, Mississippi

Some years ago, this marking was described as having the state abbreviation "MI." All examples in this census show the state abbreviation as "MIS."

Tyner, Tennessee

There are two recorded examples of this postmark. The two figures to the right of the town name have been a source of debate. Some believe figures are the word "OCT" and the numeral "9." Others that the word is "GEO" and the numeral "9" a reference to the distance from Chattanooga.

In the image below it is easy to see "OCT" and "9." Not so easy to make out "GEO."



Delisted

A Cumberland and Manteo, Virginia straight line cancels were listed in both the 1959 Dietz Catalog and the 1986 New Dietz Catalog. Conrad Bush noted that both markings were not used in the Confederate period. See Bush in "References."

Unknown

This marking is illegible and is not one of the markings listed in this census.



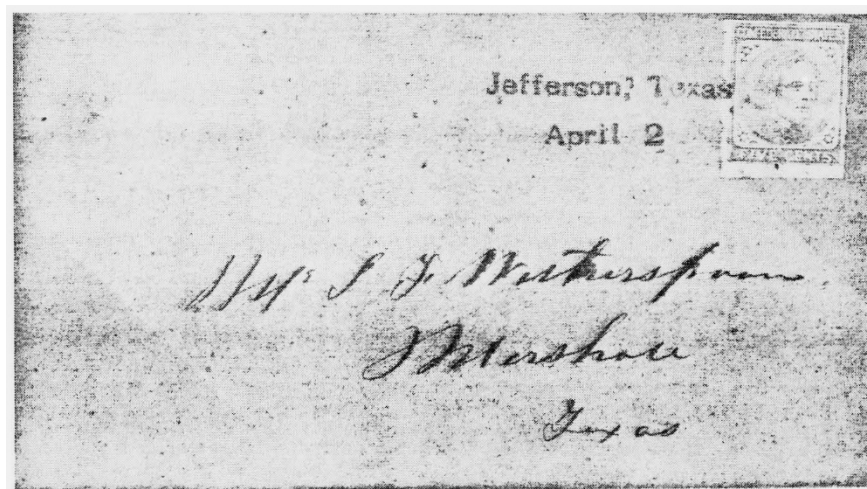

Fake

Fake Jefferson, Texas straight line postmark just ties a genuine 5c CSA #7 in the image below. The letter contains a letter dated April 1863 which immediately raises the red flags because the 5c rate ended on 30 June 1862.
